**PERMIT CONDITIONS**

Permits are required in the Town of Big Bend by ordinance for any structure or addition and certain alterations, including manufactured home or dwelling and park model trailers. A Uniform Dwelling Code (UDC) Permit is required for new 1 & 2 family dwellings and for any alterations to dwellings that were built since 1980.

Permits are valid for two years from date of issuance.

                      \$ 50.00 (\*\*Additions To Any Structure)**

**UDC Permit Applications are available from the Town Building Inspector and any fees are paid directly to inspector.**

By accepting this permit and starting construction, the applicant agrees to do only the work described on the permit application. If there are any changes to the building plan or project, the Town Clerk-Treasurer shall be notified.

Issuance of a building permit allows any town officer the right to inspect the project during the permit period.

The Building Permit card must be available upon request of any town officer. This permit is not valid unless you have obtained all required approvals from the State of Wisconsin and/or Rusk County Zoning Department.

A sanitary permit is required if the building, manufactured home or dwelling, camper, RV, etc. is intended for human habitation or if plumbing is being installed. The Sanitary Permit must, by State Statutes, be obtained from Rusk county Zoning Department prior to the issuance of the Town of big Bend Building Permit.
